Romans 12

9 Let love be genuine; hate what is evil, hold fast to what is good; 10 love one another with mutual affection; outdo one another in showing honour. 11 Do not lag in zeal, be ardent in spirit, serve the Lord. 12 Rejoice in hope, be patient in suffering, persevere in prayer. 13 Contribute to the needs of the saints; extend hospitality to strangers. 14 Bless those who persecute you; bless and do not curse them. 15 Rejoice with those who rejoice, weep with those who weep. 16 Live in harmony with one another; do not be haughty, but associate with the lowly; do not claim to be wiser than you are. 17 Do not repay anyone evil for evil, but take thought for what is noble in the sight of all. 18 If it is possible, so far as it depends on you, live peaceably with all. 19 Beloved, never avenge yourselves, but leave room for the wrath of God; for it is written, 'Vengeance is mine, I will repay, says the Lord.' 20 No, 'if your enemies are hungry, feed them; if they are thirsty, give them something to drink; for by doing this you will heap burning coals on their heads.' 21 Do not be overcome by evil, but overcome evil with good.



Aim of session



- To learn about the extent and quality of engagement with LLF across the diocese
- To reflect on the process so far, including whether misconceptions or obstacles to engagement remain
- To be informed of the next steps in the process
- To consider how further engagement might be encouraged.



The journey so far...



LIVING IN LOVE & FAITH

- Bishop's teaching morning in February 2021
- Presented at Diocesan Synod in March 2021
- Rural Deans and Lay Chairs meeting in June 2021
- Distributed free course booklets
- Provided course facilitation training
- Dean Joe & Archdeacon Sally held two open forums.





- Small number of courses have been run in person and via zoom
- 28 survey questionnaires returned
- Some positive feedback on how the course has helped participants in their learning
- Difficulties expressed with running courses due to Covid.



Process of discernment

- The College of Bishops have the ultimate responsibility for the decisions made in this process
- Data collected from the survey, independent responses, creative responses and 4-5 in-person focus groups will be gathered into a substantive report
- The substantive report (September 2022) will represent:
 - you engaged
 - you responded
 - this is what we heard.



Process of discernment

- Three residential College of Bishops meetings planned between September and December that will prayerfully reflect on LLF:
- By drawing on the report
- Through theological reflection
- Meditating on the art installation
- The Next Steps group (chaired by the Bishop of London) are considering a variety of ways to strengthen trust and transparency in the Bishops' discernment phase
- Diocesan Synods are not expected to feedback in a formal way.



Questions for discussion

- 1. Have you taken part in a course? If so, how did it help you to learn more about living in love and faith?
- 2. Are there barriers or misconceptions surrounding LLF that need to be addressed?
- 3. How might we overcome any barriers or misconceptions to the process of discernment?
- 4. How might we, as members of Diocesan Synod, encourage more people to take part in a course and respond?



DBE Measure

- New Measure about structure for all DBEs, core functions remain
- Current arrangement unincorporated board
- Options incorporated, unincorporated or statutory committee of DBF.





DBE Measure

- Process DBE, Bishop's Council and Governance Committee
- Recommendation statutory committee of the DBF
- Implementation to Archbishop's Council, then elections in autumn 2022
- Timescale from 1 January 2023.





22.07 DBE Measure

The Chair of the DBE, Bishop Mike moves that Synod:

1. "Approves the form of draft Scheme (designating St Edmundsbury and Ipswich Diocesan Board of Finance as the Diocesan Board of Education of the Diocese of St Edmundsbury and Ipswich) in accordance with the proposal submitted by the Bishop of St Edmundsbury and Ipswich with the consent of the current Diocesan Board of Education, as set out in paper DS(22)P07.1;





22.07 DBE Measure

- 2. Confirms that it is ready to make the Scheme, conditional on it being certified by the Archbishops' Council in accordance with s.23(1) of the Measure, and that accordingly, confirms the Scheme will be made and come into effect on the date specified in such certificate; and
- 3. Authorises the submission of the draft Scheme to the Archbishops' Council and requests the Bishop, Diocesan Secretary and Director of Education to take such other steps as are necessary to bring the Scheme into effect."





Questions 22.12





Colin Firth (Thingoe deanery) asked the Finance Director:

This question concerns finances for 2021.

The minutes of the Diocesan Synod on 3 October 2020 (DS(20)M1 Item 20.05.1) pointed to a budget deficit on unrestricted fund of £0.5m on the assumption that £6.4m would be received in Parish Share. The latest Parish Share report shows Parish Share of £6.008m received. Thus expected deficit would increase by £0.4m to become £0.9m.

What final deficit is now expected for 2021 and how will it be financed.





Reply from Gary Peverley, Finance Director:

With parish share received being just over £6.0m, based on budgeted parish share of £6.4m and an unrestricted fund budget deficit of £0.5m, the £0.4m parish share shortfall would in isolation lead to an increased deficit of £0.9m, as stated in the question.

However, due to the following factors, our actual 2021 unrestricted fund deficit is £0.2m, ignoring unrealised gains, such as investment revaluations:

2021 budgeted deficit	(£0.5m)
Shortfall on parish share	(£0.4m)
Shortfall on parochial fees	(£0.1m)
Sustainability funding	£0.2m
Pension deficit repayment	£0.2m
Underspends from budget	£0.4m
Actual deficit	(£0.2m)

Please note: the figures above are still subject to external audit and therefore are not finalised. The resultant ± 0.2 m deficit will be financed from our unrestricted funds and therefore will reduce the overall value of our unrestricted funds. We are again thankful to Archbishops' Council for their financial support in 2021 of ± 196 k sustainability funding which is in addition to the ± 600 k granted to us for 2020.

Sally Wainman (Colneys deanery) asked the Diocesan Secretary:

In regards to energy targets and reaching net zero carbon by 2030, would the diocese consider caution in recommending any new smart meters in churches and other buildings?

Smart meters can now send back readings every half hour to a supplier which, with surge pricing, could increase energy costs for churches. Also, smart meters can be converted remotely by a supplier to pre-paid metering, which would also be more expensive.





Reply from Anna Hughes, Diocesan Secretary:

Sally Wainman permitted us to have the time to investigate her question with the national church, there being little on the Parish Resources website to guide our answer. Noting that with the energy markets in considerable flux, this is a rapidly changing situation.

We agreed to bring the results to June Synod.
